



Hospice Savannah is committed to maintaining our exemplary level of care for patients and families as our nation grapples with the Coronavirus (COVID-19) pandemic. We are attentively and constantly monitoring CDC guidelines to ensure team members utilize correct precautions in order to continue to provide safe and outstanding care. Rest assured that your loved ones are in prepared and capable hands with Hospice Savannah throughout this extremely difficult time for our nation and our world.

Hospice Savannah, Inc. and the **Steward Center for Palliative Care** remain open and dedicated to serving you. When possible, team members will be working remotely.

Hospice House: One entrance remains open where team members and visitors are checked for fever and asked screening questions before being admitted. Visitors who are sick and/or do not pass the CDC screening at the door will not be permitted to enter the building under any circumstances. **We currently permit only two visitors in each room at a time between 10 a.m. and 9 p.m. Visitors must be screened and must wear a mask.** (Under extenuating circumstances, such as imminent end of life, or the need for extra support, temporary visitation may be granted at the discretion of the Hospice Savannah leadership team). We believe this measure of protection is essential for our patients, team members and the communities we serve, and encourage visitors to connect to loved ones through virtual means such as Skype, FaceTime or our GoToMeeting app.
